**Nationals Format & Procedures**

Time Trials/Top 50 transfer to 5 heat races.  
 Remainder transfer to last chance race.  
 Invert top 30 by times.  
 Time Trials- -In the event of a tie, the driver with the fastest  
 combined two lap time earns the spot.  
 Heats- 8 laps/Top 4 earn back times  
 C Main 10 Laps/Line up by finish  
 B Main 12 Laps/Line up by finish  
 Feature line-up/ Top 4 from each heat get time back.  
 Balance of the field start straight-up .

URC Engine Rules for all 360 motors

 URC Right rear tire - -MC2  
 Open Left Rear tire  
 Open front tires  
 2" Wickerbill. Adjustable wing allowed.  
 No other cockpit adjustable devices.  
 358's MUST strictly meet the weekly  
 Williams Grove engine rule. All other car  
 specs, including tires, must be legal per  
 the URC rule book.
